

# Immigrant Tribute Project Flight Promotion

## PROMOTION RULES

The Villa Charities Immigrant Tribute Project, Flight Prize Promotion (the “Promotion”) is sponsored by Villa Charities and Villa Charities Foundation (the “Sponsor”). To enter individuals are required to either: (a) pay for an Immigrant Tribute Plaque in full (\$1,000 CDN); or (b) write and email a 5,000 word essay on Your Family’s Italian Immigration Journey to Canada to [tributeproject@villacharities.com](mailto:tributeproject@villacharities.com) (the “Contest Email”). All entries must be received by 11:59 p.m. EDT on **June 30, 2025**. Void in Quebec and where prohibited by law.

### 1. PROMOTIONAL PERIOD

For the Flight promotion: The promotional period for the Flight Draw starts at 12:01 a.m. EDT on **May 15, 2025**, and ends at 11:59 p.m. EDT on **June 30, 2025** (the “**Flight Prize Promotional Period**”).

### 2. ELIGIBILITY

To enter you must be a legal resident of Canada who has reached the age of majority in your province. The following individuals are not eligible to enter the Promotion: Villa Charities Staff or their immediate family members; Villa Charities Board Members and Villa Charities Affiliate Board Members or their immediate family members; or residents of the Province of Quebec; or previous winners of a Villa Charities Tribute Promotion.

### 3. HOW TO ENTER

Purchase and pay in full for a Villa Charities Immigrant Tribute plaque during the Flight Promotional Period to be eligible for the draw for the Flight Prize. Alternatively, to enter the draw to win the Flight Prize on a no-purchase basis, an individual can write and email a 5,000-word essay on Your Family’s Italian Immigration Journey to Canada to the Contest Email and include their contact information including their phone number. All entries must be received by 11:59 p.m. EDT on June 30, 2025, to be eligible.

### 4. THE PRIZE

Flight Prize:

- a. The Prize includes: two (2) round-trip economy flights to Italy. The approximate retail value of the Prize is \$3,500 CDN (three thousand five hundred Canadian dollars).

- b. The Flight Prize must be accepted as awarded. The Sponsor accepts no responsibility for any costs associated with the Flight Prize that are not expressly included in the Flight Prize. In particular, the Winner is responsible for arranging and paying for his/her own transportation to and from airports, baggage and accommodations.
- c. The Flight Prize is non-exchangeable, non-transferable, and is not redeemable for cash or any other prize. The Winner is required to answer a mathematical skill testing question before being awarded the Flight Prize.
- d. The Winner agrees to provide Villa Charities with any personal information necessary to book the Flight Prize in the names of the travelers. This includes but is not limited to: full name, birth date, nationality, passport number, and date and time of travel. Once the Flight Prize is booked any changes to flight information will be incurred at the cost of the Winner.
- e. Villa Charities will pay airport taxes, fees, and surcharges imposed by the airline and government authority but will not cover any other related costs. The costs that Villa Charities will not cover include but are not limited to: baggage fees, seat selection, inflight meals, or flight upgrades.
- f. The booking of the Flight Prize flights is subject to availability through Air Canada or Air Transit. Availability is determined based on airline bookings.
- g. Villa Charities reserves the right to issue an airline gift certificate for the value of the flights in its sole and absolute discretion.

## **5. ODDS OF WINNING**

The odds of winning the Flight Prize depend upon the number of eligible entries received during the Flight Prize Promotional Period.

## **6. DATES**

The Flight Prize Draw will take place on **July 9, 2025** at 901 Lawrence Avenue West, Toronto, Ontario M6A 1C3. The Winner will be notified by phone and email within seven (7) days of the draw date. If the winner cannot be contacted, Villa Charities reserves the right to select another Winner. The Winner must contact Villa Charities Foundation to receive the Flight Prize by **August 29, 2025**, and a minimum of eight (8) weeks prior to their proposed departure with their desired flight dates. Flights prize must be redeemed and used in 2026 fiscal year.

## **7. GENERAL PROVISIONS**

- a. Villa Charities and its affiliates accept no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Promotion or accepting the Flight Prize.

- b. Villa Charities reserves the right at any time to modify or discontinue, temporarily or permanently, this Promotion with or without prior notice due to reasons outside their reasonable control (including, without limitation, in the case of anticipated, suspected or actual fraud).
- c. The decision of Villa Charities and Villa Charities Foundation in all matters relating to the Promotion is final and binding and no correspondence will be entered into with any contestants other than the selected Winner.
- d. Villa Charities and its affiliates assume no responsibility or liability for lost, late, incomplete or misdirected entries, for any error, omission, interruption, defect or delay in computer systems used to enter the Promotion, for any other communications with Promotion entrants, and are not responsible for any incorrect or inaccurate information submitted to the Villa Charities Immigrant Tribute Project website. Villa Charities and its affiliates assume no liability for any loss or damage, in the event that the Promotion is modified or terminated for any reason.
- e. The Winner must complete a Flight Prize release form and correctly answer a skill testing question unaided in order to qualify to redeem the Flight Prize.

Each individual also agrees that, if he or she is declared a Winner, Villa Charities may use his/her name, city of residence and/or photograph, without compensation, in any future publicity in connection with the Promotion and the related Tribute plaque purchase activities.
